## General Information

- Our Escape Room (EsR) is a fun and immersive experience that challenges the observational and problem solving skills of the participants.
- There are hazardous, fragile, breakable, and sensitive electronics and other components in the EsR. Please exercise due care.
- We reserve the right to refuse service or pull anyone from the EsR at any time who show misconduct or could be a hazard to property, themselves, or others.
- There are **video cameras and audio equipment** in the EsR for security and to facilitate interaction between the Participants and the Game Master.
- Audio/visual information may be used for legal purposes.

## Rules

- NO profanity or abusive language.
- NO forcing open doors, locks, or other items.
- NO defacing or damaging of the props and clues.
- NO photography. Smart phones and watches, cameras, and computers are not allowed in the game room except for storage in the locker until game's end.
- **NO removal of any objects from the EsR.**
- The game ends when the time runs out whether or not the participants have succeeded in escaping the room.
- Players **MUST** abide by these rules and obey staff at all times. Failure to comply with these rules or staff will result in termination from the game, without refund. **We will charge for the cost of damages.**
